



## Parental Notification and Opt-in Consent for Human Sexuality | Physical Education and Wellness Grade 6

Dear Parent/Guardian:

In accordance with Section 58.11 of the [Education Act](#), Alberta schools must now obtain written consent of parents prior to providing instructions or materials that deal primarily and explicitly with human sexuality, gender identity or sexual orientation. Students are unable to participate in this portion of the curriculum unless consent is explicitly granted.

As part of the Alberta curriculum, **Grade 6** students take [Physical Education and Wellness \(PE&W\)](#). In this class, they will begin learning about human sexuality in an age-appropriate and respectful way. This learning supports the outcome: **“Students investigate human reproduction from fertilization to birth.”**

Your student’s class will start learning about this topic on or after **January 5, 2026**. Please refer to the table in the attached opt-in consent form for a detailed outline of the learning outcomes addressed in this unit. Your consent is required by **December 19, 2025**.

Parent/Guardian Options:

1. **Opt-In Full Consent** – Your student will participate in all human sexuality lessons.
2. **Non-Participation** – Your student will not receive these lessons and will be provided with alternative learning tasks in a supervised setting.

Please note non-participation in these human sexuality lessons will not affect a student’s **PE&W** grade as the teacher will provide alternative learning tasks and assessments.
